- 2. Creates a new platform for international humanitarian cooperation (including cultural preservation and philanthropy) under the patronage of the House of Savoy.
- 3. Signals Armenia's European orientation, utilizing monarchical heritage as a tool for "soft power" and diplomacy in the context of EU integration.

Therefore, the Oxford Conference serves as the fundamental academic and diplomatic prelude, providing irrefutable justification for establishing a representation of the House of Savoy in Armenia, thereby strengthening its standing as a European nation deeply rooted in a shared continental history.


KEY POINTS

*The Problem: How to translate this historical claim into tangible diplomatic and strategic value today.

*The Venue: Oxford University provides the irrefutable academic justification for this geopolitical move.

TITLE

"Why This Title Matters Now: Soft Power, EU Alignment, and Cultural Security"



Actionable Outcome

Launch/Announcement Ceremony: The Armenian Royal House Foundation (or similar initiative) is launched by H.R.H. Prince Emanuele Filiberto.

*Spring 2026: Follow-up Conference in Dilijan (UWC, YSU, Matenadaran).


